Please note:

- On 21 August 2014 a facility was put in place whereby the Company can draw down up to \$500,000. The facility is repayable at the Company's option by either repayment of the amount drawn or issue of shares in the Company. A\$50,000 was drawn down under this facility in November 2014 with a further \$100,000 drawn in 2015. Under International Financial Reporting Standards this amount is classified as a liability until such time as the number of shares to repay this facility with equity can be determined. If the number of shares was calculated at A\$0.20 per share, the last sale price of the Company's shares on the ASX, at 31 March 2015 the Net Assets would have been A\$22,912 and the Net Tangible Asset Backing would have been A\$0.0009 per share.
- As at 31 March 2015 the Net Assets shown above included A\$ 79,013 in unrealised investment losses;
- The above figures are based on information available at this time and are subject to audit.
